WILDLIFE TRANSPORATION WAIVER



Waiver, Release and Indemnity Agreement

Signing This Document: Acknowledges you are doing so of your own free will. It acknowledges the Risks of Transporting & Agreement to Holding Harmless the Finder(s), Rehabilitator(s) and Connecticut Wildlife Rehabilitators Association Inc. including its officers, board, agents, hereinafter designated as "CWRA".

• Transporting Wildlife can be very rewarding- HOWEVER - it has risks!

If in the course of transporting wildlife, an injury (mental/emotional stress or physical injury) occurs to you or your property, your vehicle, etc.; the responsibility to remedy it, will be with you. You are being kind and generous with your time, helping our communities (both finders and rehabilitators) and importantly – the animals that have been injured or orphaned!!

You must clearly understand and acknowledge that before you do any transporting, you are responsible for your actions. Neither the Finder(s), the Rehabilitator(s), nor CWRA can guarantee safety!

• It is your FIRST responsibility to Keep Yourself Safe!

I acknowledge that I am transporting and offering my aid of my own free will. I acknowledge my safety is my responsibility.

I acknowledge that I have no expectation of payment from the finder(s), rehabilitator(s) or CWRA (Connecticut Wildlife Rehabilitators Association Inc. - its officers, board, agents). I am not acting as a volunteer nor am I an employee of CWRA, the Finder(s) or Rehabilitator(s). I am not eligible for any volunteer or employment benefits. There is no insurance available for me nor am I covered under workmen's compensation insurance.

I acknowledge and agree that I am responsible and that no other party can be held liable.

Hold Harmless Indemnification-

I acknowledge that CWRA (Connecticut Wildlife Rehabilitators- its officers, boards, agents), the Finder(s), or Rehabilitator(s) does not guarantee safety. I voluntarily waive, release and hold harmless the aforementioned parties from all claims, accidents, injuries, or death resulting from actions related to my transporting of wildlife. I understand this document disqualifies me from recovering damages against CWRA, the Finder(s), or Rehabilitator(s) should I be injured in the course of my duties.

I shall defend and hold harmless and indemnify, Connecticut Wildlife Rehabilitators Association Inc., its officers, board and agents, Finder(s) and Rehabilitators against all claims, accusations, notices, judgements, rulings liabilities, expenses, etc. that may exist as a result of my actions, inactions, errors, acts or omissions.
